## **THE BBEX AWARD CATEGORIES AND CRITERIA**

The **BBEX Award Program** consists of eight awards as follows:

### **1. Community Contribution**

*Awarded to a business that demonstrates exceptional support of recreation, amateur sports, arts and culture, charitable groups, or other community efforts in the Battlefords and area. Judging takes into account the relative size of the business.*

### **2. Marketing**

*Awarded to a business that demonstrates successful and innovative marketing of its business, products, or services. Marketing may include media campaigns, customer relationship building, property appearance or development, internet, or any other method the business has used to build its customer base.*

### **3. New Business Venture**

*Awarded to a new business / venture that has been operating for more than one but less than three years as of December 31, 2018. This could include the expansion of an existing business into a new venture. The new business/venture will demonstrate exceptional performance and financial viability. Judging takes into account the relative size of the business. Please note that change in ownership of a business does not, in itself, qualify the entity as a new business.*

### **4. Customer Service**

*Awarded to a business that consistently demonstrates excellence in service and/or hospitality. Criteria may include evidence of the level of service offered by the business, training and the overall success of the business. Judging will take into account the relative size of the business.*

### **5. Micro Business (Five employees and fewer, including owner(s))**

*Awarded to a small business or home office which has demonstrated significant business achievement, sustainable performance, a high level of customer service, innovation, unique differentiation and community involvement. Judging will take into account the relative size of the business.*

### **6. Battlefords' Best Employer**

*Awarded to an employer that excels in how employees are engaged in strategic goals and company values, and how human and supporting resources have been optimized to achieve and sustain commercial and competitive success. Judging will take into account the relative size of the business.*

### **7. Business of the Year**

*All applications in Award Categories 1 through 6 who become finalists, will automatically be entered into Business of the Year category.*

### **8. Heritage**

*This award recognizes pioneer and cornerstone business leaders in the Battlefords and area who have demonstrated excellence over an extended period of time and whose business has contributed to the economic well-being of the Battlefords and immediate area. The business must have been in continuous operation for at least fifteen (15) years but does not need to be currently operating in order to be eligible. Applications, for this category only, will be judged by the BBEX Committee as a whole. The successful applicant (ie. the award winner) will be announced prior to the annual event.*

## GENERAL INFORMATION FORM

The **Battlefords Business Excellence (BBEX) Awards** are open to all businesses, except Crown Corporations, operating in the City of North Battleford, the Town of Battleford, and the surrounding area. (approximately a 50 km. radius) A business may submit its own application or the application may be prepared by a third party. All applications must be signed by the business.

Businesses may submit an application in a maximum of two of the following categories:

1. Community Contribution
2. Marketing
3. New Business Venture
4. Customer Service
5. Micro Business
6. Battlefords' Best Employer
7. Heritage

All applicants in award categories 1 through 6 who become finalists, will automatically be entered into Business of the Year category.

### 8. Business of the Year

To be eligible for a category, the applicant must not have won a **BBEX Award** in **that category** in the previous two years. Once you have decided which category or categories the business is to be nominated for:

Step 1 Complete the general information form (on next page)

Step 2 Complete the application kit for the category you have chosen to enter. The questions in italics on the application kits are intended as guidelines only. Include as much information as possible as to why the applicant should win the category. There are separate kits for each category. Please note that each applicant is limited to two categories.

Step 4 All applications will be reviewed by the **BBEX Award Pre Selection Committee** which consists of three chartered professional accountants. This Committee screens all applications to ensure they are eligible, selects the finalists, and then forwards the list to the BBEX Awards anonymous jury.

Step 5 **The BBEX Awards Jury** chooses the BBEX winners. The jury is and will remain anonymous and its deliberations are completely confidential.

**Any information provided will remain confidential. Following judging, all information will be returned to you.** The BBEX Awards ceremony will be on Tuesday, October 8, 2019.
